Slips, trips & falls	Participants	3	1	3 LOW	<ul style="list-style-type: none"> - Activity should take place in spaces suitable for the activity and size of the group. - Remove or re-arrange any obstacles in the area so that it meets the needs of the activity & group (if indoors move all furniture and allow for a large activity area). - Check that all participants are wearing low heeled or flat shoes.
Collision with participants, objects or equipment	Participants	3	1	3 LOW	<ul style="list-style-type: none"> - Instruct participants to take care & be aware of other people around them. - Group leader to be vigilant & maintain group control (inappropriate behaviour must not be tolerated & participant removed from activity). - Check participants are dressed appropriately: large jewellery should be removed & long hair tied back. - Make sure all participants are aware of surroundings when throwing equipment.
Equipment failure, inappropriate use of equipment	Participants	2	1	2 LOW	<ul style="list-style-type: none"> - Equipment to be checked by Leader before & after each activity. - Group to follow instructions & safety information included with equipment.
Adverse weather conditions	Participants	1	4	4 LOW	<ul style="list-style-type: none"> - Anyone working outside must seek shelter if weather is becoming a risk, including thunder & lightning, high winds or heavy rain - Extreme caution should be taken in areas where trees increase the risk from wind due to falling debris - Volunteers/staff to wear appropriate clothing for the weather and activity - Group leader should monitor the weather and adjust their activity engagement accordingly

Existing medical condition	Participants	2	3	6 LOW	<ul style="list-style-type: none">- Leaders to ensure the appropriate health & parental consent forms are used.- Ensure necessary medication available if needed.- Ensure all leaders are aware of the OAC's accident/emergency procedures.- Group to have access to a mobile phone.

Likelihood of occurrence X Severity of outcome = Risk Rating

Example:

Likelihood (possible 3) X Severity (Moderate 3) = Risk Rating (Medium 9)
